### 1. CALL MEETING TO ORDER

Vice President Sinclair called the Regular Meeting to order at 9:00 a.m.

2. PUBLIC COMMENT – Please limit comments to 3 minutes.

3. CONSIDERATION AND POSSIBLE ACTION ON MINUTES FROM AUGUST 6, 2024

Director Peterson motioned to approve the minutes from the August 2024 Regular Meeting minutes on August 6, 2024. Director Breeding seconded. The motion passed unanimously.

## 4. CONSIDERATION AND POSSIBLE ACTION ON EXPENDITURES

a) July 2024

Director Spearman motioned to approve the July 2024 expenditures, seconded by Director Stockett. The motion passed unanimously.

b) August 2024

General Manager Britten noted that the District is tracking to be on budget for the 2023-2024 fiscal year. She noted that there are some additional expenses, which are related to one of the District airplanes, will warrant future discussions related to finding a replacement.

Director Peterson motioned to approve the August 2024 expenditures, seconded by Director Stockett. The motion passed unanimously.

5. CONSIDERATION AND POSSIBLE ACTION ON ADOPTING THE PROPOSED 2024-2025 TAX RATE

Britten noted that the tax rate had been properly posted according to the tax code and there was no written public comment.

Director Peterson motioned to adopt the proposed tax rate of \$0.008163/\$100 valuation for the 2024-2025 tax year, seconded by Director Breeding. The motion passed unanimously.

6. CONSIDERATION AND POSSIBLE ACTION UNDER RULE 3.3 ON AN OVERDUE ENFORCEMENT PENALTY RESULTING FROM OVERPRODUCTION ON THE MAXIMUM ALLOWABLE VOLUME ON OPERATING PERMIT NUMBER 65123601

General Manager Britten notified the Board that she was able to make contact by phone with the Operator for Operating Permit number 65123601 and spoke to him regarding the overdue enforcement penalty and that he was informed that if further action were to be taken, he would be liable for any related attorney fees. She stated that the Operator said he would come by the District office to make payment arrangements but has not done so at this time.

The Board agreed that they recommend the District to seek legal counsel to take over the collection of the penalty fees for Operating Permit 65123601.

Director Stockett motioned to have the District Attorney send certified letters to both the landowner and operator with outstanding balances for Operating Permit 65123601, seconded by Director Spearman. The motion passed unanimously.

7. CONSIDERATION AND POSSIBLE ACTION ON AUDIT CONTRACT WITH ARTURO ORTEGA CPA

General Manager Britten stated that Ortega has conducted financial audits for the District in the past and the audit usually occurs in December with the results presented to the Board in January.

Director Bowers motioned to approve the audit contract with Arturo Ortega CPA, seconded by Director Breeding. The motion passed unanimously.

Director Spearman motioned to approve all well reclassification requests, seconded by Director Stockett. The motion passed unanimously.

- 1. Frank Wiebe A 4" well to be drilled on 305 acres by First Priority to be drilled by 9.4.24 located in the NE4 of Section 33, Blk HD, JC Barnett Survey (being located NE of Hedley on Hwy 208 approx. 2 mi to FM 2695, follow FM 2695 NE approx. 7 ½ mi, W side of FM 2695) **DONLEY COUNTY**
- 2. Frank Wiebe A 4" well to be drilled on 305 acres by First Priority to be drilled by 8.14.24 located in the NW4 of Section 32, BLK HD, JC Barnett Survey (being located NE of Hedley on Hwy 203 approx 2 mi to FM 2695, follow FM 2695 NE approx. 6 ¼ mi, N side of FM 2695) **DONLEY COUNTY**
- 3. Energy Transfer A 2" well to be drilled on 28.09 acres by 3T Drilling to be drilled by 9.4.24 located in the SW4 of Section 152, Blk 3, I&GN Survey (being located approx. 4 mi E of Pampa city limits on Hwy 60 to CR 3, N on CR 3 approx 1 mi, E side of CR 3) **GRAY COUNTY**

Director Spearman motioned to approve all drilling permits for wells pumping more than 17.5 gallons per minute, seconded by Director Hardcastle. The motion passed unanimously.

### 9. DISCUSSION OF DISTRICT RULES

General Manager Britten stated that attorney Monique Norman has drafted some rule changes regarding smaller acre tracts (less than 10 acres) to propose to the Rules Committee at a future meeting date. These changes would be in line with exemptions within Chapter 36 of the Texas Water Code. Britten recommended the Rules Committee meet before the next regularly scheduled Board meeting.

The Directors asked Britten about a possible water quality issue within the District. Britten stated that the District reported a possible water quality contamination issue to the Texas Commission on Environmental Quality (TCEQ) who then issued the Operator a violation citation. The District is still waiting for the official written outcome from TCEQ, and she will update the Board when she receives the letter from TCEQ.

- A) General Manager Britten presented her report to the Board of Directors in the Board Packets, which included past and upcoming meetings, District public education events, District well statistics, and a weather update.
- B) Britten announced that the Management Plan has been approved by TWDB with no changes and that she is waiting for the certificate from TWDB before posting the newly approved Management Plan on the District's website.
- C) Britten stated that the 89<sup>th</sup> Legislature begins in January 2025. Some of the main topics of discussion may include large scale production permits, waste, and amenity ponds. Additionally, she noted that Senator Perry from Lubbock is expected to propose a new water supply plan during the next session which would include the use of treated produced water to be supplied to municipalities by a pipeline network system to lessen municipal reliance on groundwater resources. Sen. Perry also wants to plan like the state does for roads and bridges by having a dedicated state fund for water infrastructure projects.
