
# PGCD BOARD OF DIRECTOR UPCOMING ELECTION

DEADLINE TO FILE AN APPLICATION ON THE BALLOT FOR THE MAY 3, 2025 ELECTION

The application period to file a place on the ballot for the upcoming Board of Director election is January 15, 2025 through February 14, 2025. Applicants can apply in person at the District office in White Deer or may request an application by email, mail, or fax by calling 806-883-2501.

Applicants must reside within the Precinct they intend to run. The following Board members' terms expire this year: Devin Sinclair, representing Precinct 1, John R. Spearman, Jr., representing Precinct 3, Chancy Cruse, representing Precinct 5, William (Bill) Breeding, representing Precinct 7, and Lee Peterson, representing Precinct 9.

\*\*\*Please note, if any person runs unopposed (meaning there is only one application to be put on the ballot), the governing body has the statutory authority to cancel the election as directed in the Texas Election Code. ### TWDB AGRICULTURE LOAN NOW AVAILABLE

PGCD has received an agricultural conservation loan from the Texas Water Development Board (TWDB) in the amount of \$1,000,000 to help local producers purchase center pivot sprinklers, drip irrigation systems, soil moisture probes, and other water-saving equipment. Applications are reviewed on a first come, first served basis. The current interest rate is 5.23% with an eight-year payback term. # MASTER IRRIGATOR REGISTRATION OPEN

The Master Irrigator Program is an irrigation management curriculum made up of 32 hours of intensive irrigation education conducted over four one-day sessions to show producers how to advanced conservation maximize irrigation Plains North Groundwater management. ## TEXAS GROUNDWATER LEGAL UPDATES

Two Texas federal courts recently issued rulings in favor of groundwater conservation districts, upholding the districts' rules and enforcement of fines for overproducing the permitted production allowable. Groundwater districts are created by the Texas Legislature to conserve, protect, and preserve aquifers and adopt rules to manage those resources. PGCD prefers to resolve enforcement issues amicably, rather than initiating an enforcement matter. However, permit and rule enforcement is necessary to minimize as far as practicable the drawdown of the water table so that the area's aquifers remain viable as a water source for future generations of the Panhandle.

Judge Matthew J. Kacsmaryk, a United States District Judge for the Northern District, Amarillo Division, ruled in favor of the NPGCD on several claims. The Plaintiff, irrigated who grows potatoes with groundwater from the Ogallala Aquifer, exceeded the Allowable Annual Production in its permits issued by the district under its adopted rules. The district issued significant fines for the overproduction and was sued for an unconstitutional regulatory taking of its real property. The Court ruled in favor of district on motions for summary the judgment, as there was no genuine dispute of material fact and the district was entitled to judgment as a matter of law on the takings, due process, and other claims.

In Central Texas, a federal court in the Western District, Austin Division, ruled in favor of the Hays Trinity Groundwater Conservation District and dismissed claims from a retail public utility challenging the district's authority to issue fines for exceeding its production permits. The Court dismissed the issue, citing to § 36.102 of the Texas Water Code, which allows groundwater districts to enforce its rules through fines and injunctions.
