- 3. CONSIDERATION AND POSSIBLE ACTION ON AN APPLICATION FOR PROPERTY TAX ABATEMENT UNDER CH. 312 OF THE TEXAS TAX CODE, DESCRIBED AS FOLLOWS:
  - a. <u>Property Owner(s)</u>: Amarillo Economic Development Corporation, a Texas nonprofit corporation. The Property is expected to be leased to Unmanned Systems, Inc. d/b/a Albers Aerospace, a Nevada corporation, or related entity.
  - b. Applicant(s) for Tax Abatement: Unmanned Systems, Inc. d/b/a Albers Aerospace, or related entity.
  - c. <u>Enterprise / Reinvestment Zone:</u> Reinvestment Zone No. 20, being approximately 30 acres abutting the southwest portion of the taxiway at Rick Husband Amarillo International Airport in Potter County, Texas.
  - d. <u>Anticipated Improvements:</u> Construction of one or more aircraft hangars totaling an aggregate of approximately 200,000 square feet, and related site and utility improvements.
  - e. Estimated Cost of the Improvements: Approximately \$50,000,000

- 4. CONSIDERATION AND POSSIBLE ACTION ON AN APPLICATION FOR PROPERTY TAX ABATEMENT UNDER CH. 312 OF THE TEXAS TAX CODE, DESCRIBED AS FOLLOWS:
  - a. Property Owner(s): Tyson Fresh Meats, Inc., a Delaware corporation.
  - b. Applicant(s) for Tax Abatement: Tyson Fresh Meats, Inc., a Delaware corporation.
  - c. Enterprise / Reinvestment Zone: Potter County Reinvestment Zone No. 1, being approximately 436.59 acres in Potter County, Texas, at 5000 N. FM 1912, Amarillo, Texas 79108 further described by the Potter-Randall Appraisal District as Property ID 220430, Geographic ID R-200-0190-0001.0, and SECT 19 A B & M BLK 0002, NORTHERLY 443.04 AC LYING NORTH OF U S HIWAY 60 LESS WEST ROW, 436.5900 ACRES, POTTER COUNTY, TEXAS.
  - d. <u>Anticipated Improvements:</u> Expansion of Applicant's harvest floor and animal welfare improvements.
  - e. Estimated Cost of the Improvements: Approximately \$200,000,000

John R. Spearman made the motion to approve a 10-year 100% tax abatement for year one, with a reduction of 10% each year for the following nine years for Tyson Fresh Meats. Seconded by Devin Sinclair. Motion passed unanimously
